

What is happening?

On March 21, 2022, 9:00 AM Sydney, Australia Time (GMT +11), Ivanti will begin migrating all the content from the Cherwell Learn Learning Management System (LMS) to the Ivanti Advantage Learning LMS.

The Ivanti Advantage Learning LMS will go live with the migrated Cherwell Learn content on March 28, 2022, 9:00 AM Sydney, Australian Time (GMT +11).

What does this mean to you?

You will be unable to access Cherwell Learn as of March 21, 2022, 9:00 AM Sydney, Australia Time (GMT +11) as we migrate your learning transcript and education subscriptions as well as courses you are registered for and all course completions. Additionally, all current Cherwell learning content and courseware from the Cherwell Learn LMS will be migrated.

What immediate action do you need to take?

We recommended you complete any course work that is "in progress" by March 21, 2022. Any record of "in progress" at the time of migration will result in this record not being captured and you will restart the course(s) from the beginning once migrated to the Advantage Learning LMS.

When is the Cherwell Learn LMS moving to the Ivanti Advantage Learning LMS?

Ivanti IT and Advantage Learning Operations will move all the content from Cherwell Learn to Ivanti Advantage Learning, the week of 21-March-2022.

What is moving from the Cherwell Learn LMS?

All current Cherwell learning content, courseware and student transcripts and education subscriptions are moving to Ivanti Advantage Learning.

What happens to my in-progress courses?

If you do not complete your in-progress course before the migration begins, you will be required to restart the course(s) from the beginning in Ivanti Advantage Learning.

What about my Cherwell Learn transcript?

Your Cherwell Learn transcript will be migrated over.

Will I be able to access Cherwell Learn after March 28, 2022?

No. The Cherwell Learn LMS will no longer be accessible after March 21, 2022

When and how do I access Ivanti Advantage Learning LMS?

Ivanti Advantage Learning LMS will be available beginning March 28, 2022, 9:00 AM Sydney, Australia Time (GMT +11). You will receive instructions for accessing the Advantage Learning LMS in advance of its availability.

How do I know if my course is marked complete in Cherwell Learn?

You will see the course listed in Cherwell Learn under your Completed tab under you're My Learning tab.

Anything not started or in progress shows under your To Do tab.

I want to check that I've completed all my courses in Cherwell Learn, how do I do that?

Log into Cherwell Learn and click on My Learning from the menu and look at the listing under the Completed tab.
